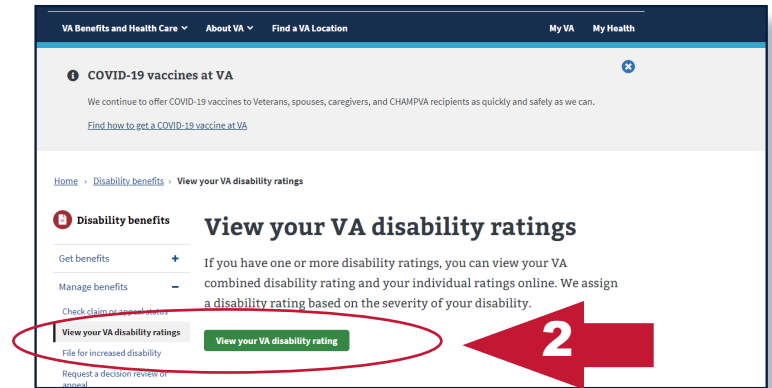

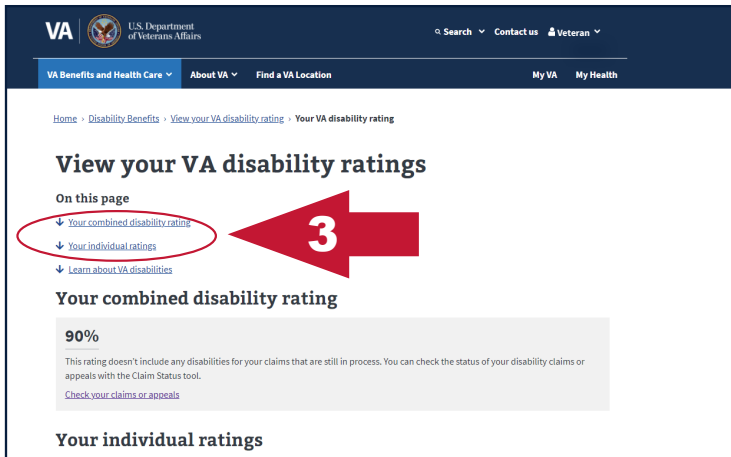
1. Navigate to **Disability**.



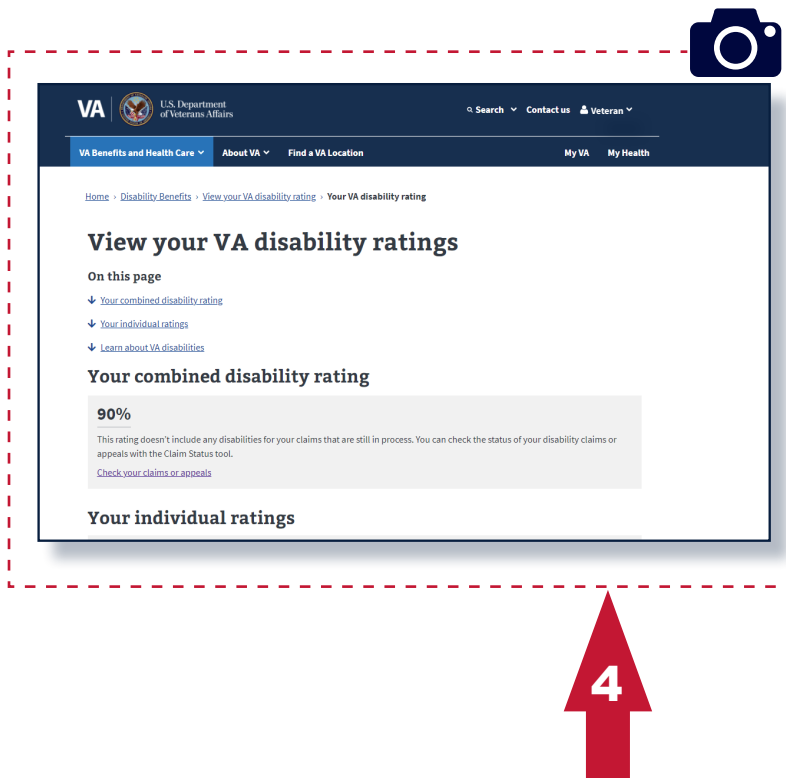
2. Click on **View your VA disability rating**.

4. Screenshot your combined disability rating and all individual ratings.

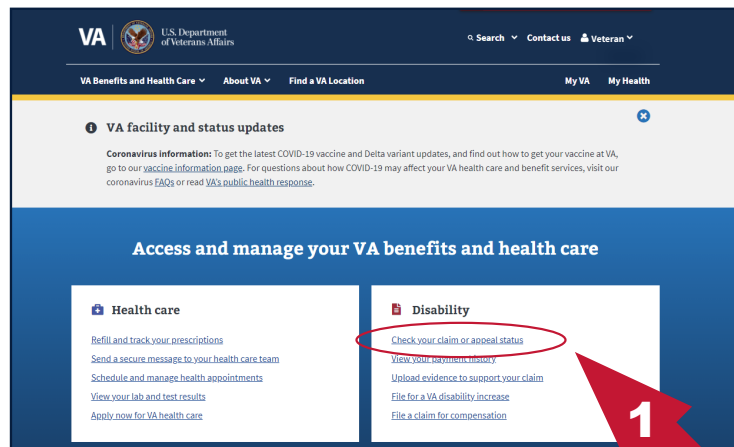

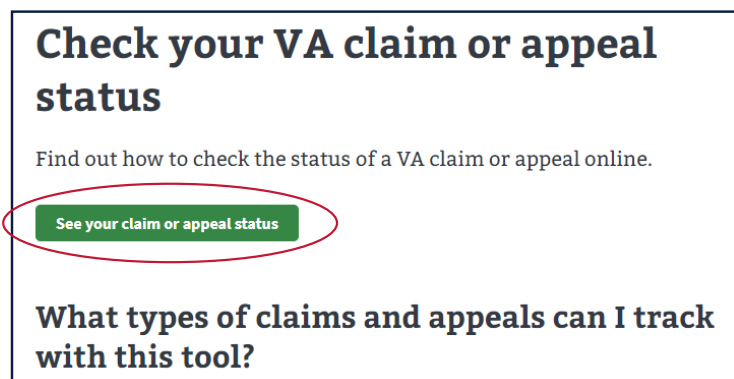

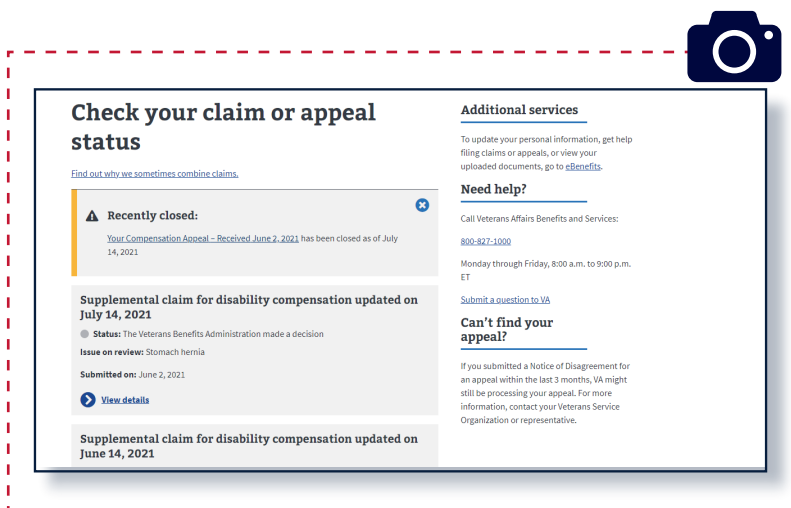

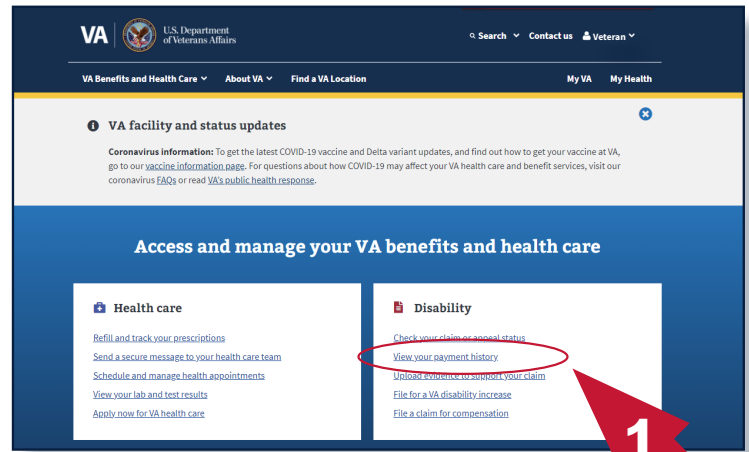

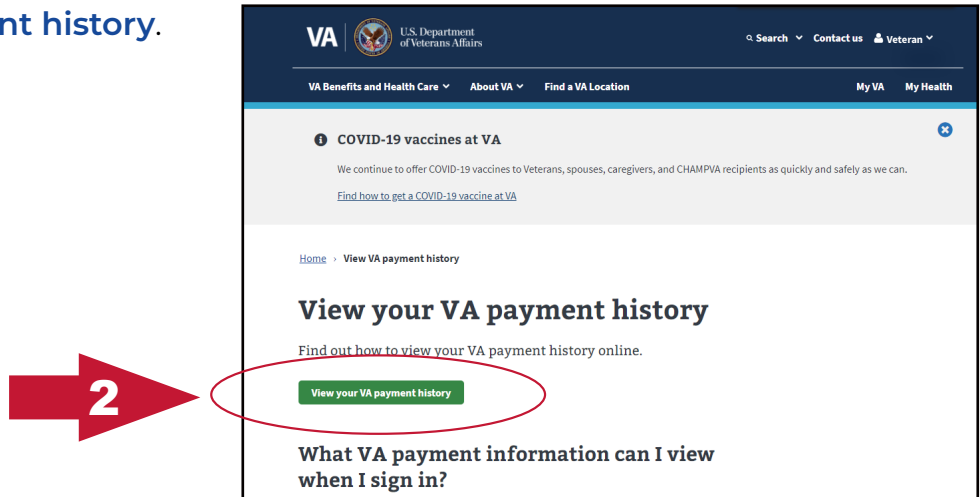
